The Board of Directors of the Company hereby announces that with effect from 26 January 2022, Ms. Grace Choong Mai Foong (“**Ms. Choong**”) has resigned as an independent non-executive Director, the Chairwoman of the remuneration committee of the Board (the “**Remuneration Committee**”), a member of each of the nomination committee of the Board (the “**Nomination Committee**”) and the audit committee of the Board (the “**Audit Committee**”) as she would like to devote more time to her own profession and business.

Ms. Choong has confirmed that she has no disagreement with the Board and there is no matter in respect of her resignation that needs to be brought to the attention of the shareholders of the Company (the “**Shareholders**”) or The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The Board would like to take this opportunity to express its sincere gratitude to Ms. Choong for her valuable contributions to the Company during her tenure.

## **APPOINTMENT OF INDEPENDENT NON-EXECUTIVE DIRECTOR AND MEMBERS OF BOARD COMMITTEES**

The Board is pleased to announce the appointment of Ms. Wong Shuk Yee Camilla (“**Ms. Wong**”) to the following offices, all effective from 26 January 2022:

1. an independent non-executive Director;
2. the Chairwoman of the Remuneration Committee;
3. a member of the Nomination Committee; and
4. a member of the Audit Committee.

The biographical particulars of Ms. Wong are set out below:

Ms. Wong, aged 51, graduated from The University of Birmingham with Master of Social Science (Money Banking and Finance). Ms. Wong has over 12 years of financial planning and management experiences. She is the member of The Chinese Institute of Certified Financial Planners and Institute of Financial Planners of Hong Kong and she also qualified as Life Underwriter Training Council Fellow.

The Company has entered into a letter of appointment with Ms. Wong in relation to her appointment as an independent non-executive Director of the Company for a term of one (1) year commencing on 26 January 2022 which is determinable by either party serving on the other not less than one month’s written notice, subject to retirement by rotation and re-election in accordance with the articles of association of the Company and the GEM Listing Rules. Ms. Wong will be entitled to a Director’s fee of HK\$72,000 per annum, which was recommended by the Remuneration Committee and has been determined with reference to the prevailing market conditions and her roles and responsibilities in the Group, subject to review by the Board and the Remuneration Committee from time to time. She has not entered into nor proposed to enter into any service contracts, which fall within the meanings of Rule 17.90 of the GEM Listing Rules requiring the prior approval of shareholders of the Company at general meetings, with the Company.

As at the date of this announcement, save as disclosed above, (i) Ms. Wong does not hold any other position with the Company or its subsidiaries nor have any relationship with any director, senior management, substantial shareholder or controlling shareholder of the Company; (ii) Ms. Wong has not held any directorships in any other public companies, the securities of which are listed on any securities market in Hong Kong or overseas in the last three (3) years; and (iii) Ms. Wong does not have any interest or short positions in any shares, underlying shares or debentures of the Company or any of its associated corporations within the meaning of Part XV of the Securities and Futures Ordinance

(Chapter 571, the Laws of Hong Kong). Ms. Wong has confirmed that she met the independence criteria set out in Rule 5.09 of the GEM Listing Rules. Save as disclosed above, there are no other matters relating to Ms. Wong's appointment that need to be brought to the attention of the shareholders of the Company nor any information to be disclosed pursuant to Rules 17.50(2)(h) to 17.50(2) (v) of the GEM Listing Rules.
